APF 730-1 FACILITY RENTAL RATES POLICY 730 COMMUNITY USE OF FACILITIES



Effective September 2024

1. GENERAL

- 1.1 Applicant groups are permitted access to school space for the <u>exact times</u> specified on the permit and should not enter the facility ahead of or stay past their designated rental time.
- 1.2 School Programs may pre-empt booking (s). In such instances, the Applicant (Permit Holder) will be notified, and a credit or refund will be applied (if applicable).
- 1.3 Payment is due in full upon permit approval.
- 1.4 The School District currently accepts the following forms of online payment: Visa or Master Card.
- 1.5 Monthly payment schedules are acceptable subject to approval through the Secretary-Treasurers office or designate.

2. BOOKING COSTS

2.1. Booking costs are applied after the Facility Rentals Department has confirmed availability and approved the application. All fees are subject to 5% PST.
