i) Assistant Superintendent's Report: Cheryl Lenardon

- Cheryl updated FNEC on First Nations Cultural spaces at Lake City Secondary Campus':
- Cheryl spoke about the NITEP learning experiences
- Pro D session planned for February 12, 2021 by Dancing Water Sandy.
- We are working to keep students connected to their schools.
- FNEC will be asked for feedback next meeting on the District Strategic Plan.

ii) Superintendent's Report: Chris van der Mark

- Chris thanked Education Coordinators for helping to keep their communities safe and ours as well.
- Chris thanked Jerome and Ed Coordinators for working together on keeping track of students.
- Announcement on new Covid guidelines and changes in schools was explained.

iii) Finance, Facilities & Transportation Committee Report: Chris Van der Mark

- Chris explained how the Federal Government funding was utilized to increase technology.
- Budget: We may have some things to consider for next year; if students do not come back to school by September.
- Chris explained Provincial funding was used for items including personal protective equipment, hygiene supplies and enhanced cleaning.

iv) Education Committee: Chris van der Mark

- Chris explained that a suggested shut down of schools was not within his powers. All
 communities have had different lock down times as well. We have tried to support
 their needs as best we can and we will continue to do that.
- Every month Jerome has been taking the Board through the LEAs and also working with the Principals. This is really valuable work.
- SD27 received higher completion rates last year for all students. First Nations were at 72.5% this is a positive step.
- Floyd to take Sr. staff through some local language.
- Federal funding used for Outdoor learning spaces received and ability to get the outdoor spaces going.
- Trying to move things forward in a complex and challenging time.

v) Policy Committee: Chris van der Mark

• Policy committee: key policy changes to be aware of is especially now it's cold. Buses no longer automatically cancelled at -32.

vi) First Nations Education Department Budget Report: Jerome Beauchamp

- Jerome shared the update of the budget. Updated budget document will be forwarded to members next week.
- Construction of Outdoor Learning Spaces at Columneetza and WL Campus' will commence in the spring.
- Our district has had a direct focus on on-reserve students to see what their needs are.
 We have been phoning families directly to see what students need to be able to learn from home.
- Ensuring teachers are well connected to their students.
- Helping students with the Teams connection as well.
- Working with Education Coordinators to be able to follow their students' progress.
- Our Transitions Workers have been working really hard with students; especially grade 6 and grade 12 students at the moment.
