- 2024 Role Model Registration is on the website and in the schools.
- The Role Models helped with registration table at Lake City Secondary on Oct. 24th and Columneetza Jr. Secondary on October 25th encouraging their peers. There was a role model registration booth at PSO on October 26 as well.

These decisions need to be made by third week of January when registration for the coming year commences. Communities need to be ready for this.
